GUIDELINES FOR ADMISSION OF 2ND AND 3RD YEAR STUDENTS ADMISSION

<u>2023-24</u>

- 1. Admission of 2nd/3rd year students shall be done online on ERP portal <u>https://erp.highereduhry.ac.in</u>.
- 2. Click on <u>https://erp.highereduhry.ac.in</u> to open the portal for fee payment and login with user id and password provided by the college.
- 3. After login portal will redirect to the dashboard.
- 4. In the student basic info tab, students are directed to cross-check their basic details if there is any discrepancy in their personal details or subject combination, then immediately report to the respective clerks **before fee payment**.
- 5. After that click on the pay fee option.
- 6. ERP Portal shall be opened for admissions from 10.07.2023 to 31 .07.2023 without a late fee. After 31.07.23 late fee is proposed as under:
 - A. Late Feer from 01.08.2023 to 07.08.2023 =Rs. 100/-
 - B. From 08.08.2023 onwards = Rs. 100 + Rs. 100/ per day
- 7. All the students have to **fill out the admission form (attached below)** along with the following documents:

- c) Fee receipt generated from the portal
- d) 2 passport size Photographs
- e) Family Id
